- Motion by Ms. Drinkwater to eliminate overdue fines immediately for all Iberville Parish cardholders who live, work, or go to school in Iberville Parish. Second by Ms. Orcino. Motion passed.
- Instruction to Ms. Seneca to have a formal board policy reflecting the decision written for the November board meeting.

#### **Financial Updates**

#### <u>3<sup>rd</sup> Quarter Budget Amendments</u>

- Ms. Seneca presented the current state of the budget and requested one budget amendment to award staff raises with November instead of January.
- Motion by Ms. Orcino to implement a 3% salary increase for all library staff, to start with the November 2, 2023, paycheck. Second by Ms. Obier. Motion passed.

#### Credit Card Acceptance

- Ms. Seneca reported an increasing number of library patrons request to pay for library charges by credit/debit card.
- Library board agreed this is a service that should be explored and instructed Ms. Seneca to do so.

#### <u>Reserve Funds</u>

- Ms. Seneca asked the board if they wished to set a policy on the amount of reserve funds retained for building maintenance and emergency repairs.
- Motion by Ms. Obier to keep reserve funds at 1.5 million dollars and not dip below that amount without board approval. Second by Ms. Drinkwater. Motion passed.
- Instruction to Ms. Seneca to write a formal policy on this for November board meeting.
